Eligibility	<p>All competitors must be aged 8 years to 15 years on the day of the event and hold a valid BJA membership or equivalent.</p> <ul style="list-style-type: none">Competitors must hold a full membership, under 8 and introductory memberships are not valid for competitions. <p>All competitors aged 9 and over must have completed a grading examination within the last 9 months (applies to novices if licence held over 6 months). Please ensure your current grade has been added to your record book and signed by the club coach.</p>	
Categories	<p>A: Under 12 Orange Belts & Below (players aged 8-11 years) BJA U12 Restrictions will apply</p> <p>B: 12-15 Years Blue Belts & Below (players aged 12-15 years) No Armlocks or Strangles</p>	
Method of Elimination	Where possible players will be divided into pools of three or four in each event based on gender and weight. The Tournament Director reserves the right to combine or alter categories if entries dictate.	
Weigh-In	Category A – 8.30am to 8.50am Category B – TBC Will be communicated by email and published on our Facebook page.	All competitors MUST present themselves to the weigh-in wearing competition acceptable judogi trousers and a plain white, round neck t-shirt / rashguard.
