

# **England Development Squad Identification Policy**

# Pre Cadet, Cadet, Junior September 2025 – August 2026

# Introduction

England Judo's commitment to fostering excellence begins at the earliest stages, nurturing young fighters as they progress through each level of the sport. The journey for aspiring judoka starts with the Pre Cadet, Cadet, and Junior categories, providing a structured and supportive environment for skill development and growth.

The England Talent Programme is designed to support British Judo's Olympic and Paralympic objectives. The England Development Squad (EDS) serves as the main approach for identifying athletes within the pathway. Its aims include:

- Identifying potential athletes for future British Judo Olympic and Paralympic teams;
- Supporting athletes to perform at the Junior World and Junior European Championships;
- Assisting athletes in their preparation and transition to the World Class Performance Programme; and
- Developing an inclusive talent programme to include fighters from diverse backgrounds within the England judo community.

The EDS offers a programme of continuous personal development which includes technical, tactical, physical, psychological and lifestyle support. This is delivered through training camps, based at the British Judo Olympic & Paralympic National Training Centre, and opportunities for international competition.

## **Eligibility**

To be eligible for the EDS, fighters must meet the following criteria:

- Hold a current BJA licence or affiliate membership;
- Hold a valid British passport or meet the IJF/EJU policy requirements regarding refugees. See the IJF rules here: <u>IJF Rules</u>;
- Signed 2025/2026 England Programme Fighter Agreement, see Appendix 1 of the EDS Information Booklet: and













 Meet the appropriate grade / age criteria for each squad as per the table below:

Cadet	10 <sup>th</sup> Mon/3 <sup>rd</sup> Kyu (green belt)	2009 to 2011
Junior	2 <sup>nd</sup> Kyu (blue belt)	2006 to 2011

#### Identification

The criteria for invitation onto the EDS programme is based around participation and commitment to the sport of judo along with specific performance measures at cadet and junior level.

There are two main identification routes:

- 1. Primary Invites will be offered in September following the English Closed Championships.
- 2. Secondary Invites may be offered in December following the British Championships.

The England Talent Programme reserves the right to offer places based on criteria including, but not limited, to:

- Achievement of the Performance Identification Criteria.
- Attendance at the English Closed Championships or approved reason for not being in attendance.
- Previous performances of the fighter.
- Age and stage of development of fighter in their age group.
- Performance level of the relevant weight category and age group.
- Competitiveness of the relevant weight category and age group.

# **Co-Option Application**

Fighters not directly identified by the England Talent Programme, who want to be considered for the EDS, may submit a Co-Option Application. Fighters will be required to include details on their performances over the previous 12 months.

Co-option applications will be considered up until April 2026.

## **International Camp and Competition Opportunities**

An important part of the EDS programme is the opportunity to compete internationally as part of the England team. England Judo aims to provide self-funded international competition opportunities to as many fighters as possible. England Judo, as a minimum, will offer 2 competition opportunities to EDS training group 1 fighters and 3 competition opportunities to EDS training group 2 fighters.
